The Council typically meets on Tuesday after the second Monday of March, June, September, and December. A Conference Room will be reserved for Council Standing Committee meetings for the Monday prior to each quarterly meeting.

To conform with the codifier's schedule for the publication of notices in the North Carolina Register and to meet the statutory deadline requiring that amendments to the North Carolina Residential Code (and five other code volumes) be finally adopted by the Council prior to June 30, 2024, it is proposed that the March 2024 quarterly meeting be scheduled to occur on Tuesday after the *third* Monday of the month, **March 19, 2024**. Subsequent meetings will return to the Tuesday after the second Monday in June, September, and December 2024.

**A room suitable for hearings will be reserved for the last Wednesday of January, April, July, and October for the Council to hear appeals.**
