VOLUNTEER RESCUE/EMS FUND

Under N.C.G.S. 58-87-5, this funding opportunity was created through the Department of Insurance to provide Rescue/EMS grants to volunteer rescue units, rescue/EMS units, EMS units that are volunteer fire departments that are part of a county's EMS system plan, and EMS units providing rescue or rescue and emergency medical services to purchase equipment and make capital improvements. The State Treasurer shall invest the Fund's assets according to law, and the earnings shall remain in the Fund. On December 15, or on the first business day following December 15, if December 15 falls on a weekend or a holiday, of each year, the Department of Insurance shall make grants to eligible departments subject to all the following limitations:

1. A grant to an applicant who is required to match the grant with non-State funds may not exceed twenty-five thousand dollars (\$25,000), and a grant to an applicant who is not required to match the grant with non-State funds may not exceed three thousand dollars (\$3,000).
2. An applicant whose liquid assets, when combined with the liquid assets of any corporate affiliate or subsidiary of the applicant, are more than one thousand dollars (\$1,000) shall match the grant on a dollar-for-dollar basis with non-State funds.
3. The grant may be used only for equipment purchases or capital expenditures.
4. An applicant may receive no more than one grant per fiscal year.
5. The grant may be used only for purposes related to services that the department is authorized to provide.

A Rescue/EMS department is eligible for a grant through this fund if:

1. It consists entirely of volunteer members, with the exception that the department may have paid members to fill the equivalent of 10 full-time paid positions.
2. It has been recognized by the Department of Insurance as a rescue department, a rescue/EMS unit, or an EMS unit.
3. The Rescue/EMS department must meet the eligibility criteria of the NC Association of Rescue & EMS (NCAREMS) and/or NC Office of Emergency Medical Services (NC OEMS).
4. County recognizes Rescue/EMS department as providing rescue or rescue/EMS or EMS.
5. Rescue/EMS department must be certified by the Office of Emergency Medical Services to request ALS equipment.

The major emphasis of this program is Rescue/EMS safety. Rescue/EMS safety equipment receives the highest priority. Requests for vehicles and capital expenditures are also considered. Each application is reviewed and scored using a non-subjective point system. The point system is based on each aspect of an application's per capita income, number and age of vehicles (only if requesting a vehicle), whether the department is all volunteer or paid personnel, financial status and the type of equipment requested.

Every eligible rescue/EMS unit in North Carolina was notified on the online application and a detailed letter of instruction was emailed on August 1, 2023. Online applications were accepted through October 1, 2023.

There were 201 applications received for evaluation, of these 99 Rescue/EMS departments received matching funds through the Volunteer Rescue/EMS Fund. There were 102 applications withdrawn, disqualified, or incomplete.

Attached to this report you will find a list of approved departments by county, along with the amounts they were awarded.

All Rescue/EMS departments submitting a Volunteer Rescue/EMS Department Fund applications were notified by email of their approved or non-approved status on December 15, 2023.

Approved Rescue/EMS departments are presently purchasing and receiving their approved equipment. Upon delivery of their equipment, they will upload their documentation (invoices and proof of payments) for reimbursement. The deadline for submitting this information to the Department of Insurance is April 30, 2024.

The checks are delivered by mail or electronic transfer funds will be deposited to each approved Rescue/EMS department once all grant requirements are met. The equipment purchased through this grant must remain in the possession of the department for a minimum of five years and is subject to inspection or audit which is carried out by our Inspections Staff.

For the Volunteer Rescue/EMS Fund, N.C.G.S. 58-87-5 requires grants to be awarded on December 15.

As a result, the grant cycle is usually from November 1 through October 31 for each year. In 2022 November 1 was used as the start of the grant cycle, making the grant year 11/1/2022 to 10/31/2023 In 2022, November 1 again used as the start of the grant cycle for the 2022 Grant Year, but the grant cycle will end on October 31 to return to the usual grant cycle.

N.C.G.S 58-87-5 requires this report to be filed with the legislatures within 60 days of awarding the grants which is before the grant cycle for the awards has ended. Because of this we think it is appropriate to report the beginning fund balance, cash receipts, cash disbursements and ending fund balance for the previous grant cycle (and the ending fund balance would be the beginning balance for the new grant cycle).
