Ongoing Projects: The NC Code Officials Qualification Board (NCCOQB) staff are actively developing 17 new Board courses, worksheets, and state exams to align with the 2024 NC Building Code updates. Additionally, the Home Inspector License Board (NCHILB) staff are implementing strategic priorities identified during the October workshop to advance the Board's goals.

# FOAM Update: AFFF Inventory and Disposal Progress

The Office of State Fire Marshal (OSFM), in collaboration with the NC Collaboratory, continues its efforts to manage Aqueous Film-Forming Foam (AFFF) inventory and disposal:

- Visit us at the NC Fire Chief's Mid-Winter Conference: The NC Collaboratory will host a booth at the conference, featuring OSFM Foam Analysts. Departments are encouraged to stop by to complete their AFFF inventory for 2025. This inventory initiative will continue through the spring and summer.
- AFFF Disposal Efforts Underway: The NC Collaboratory is finalizing bids for the destruction of AFFF currently in storage at the Charlotte warehouse. Once this inventory is disposed of, AFFF collection from departments will resume.
- Reporting AFFF Spills or Usage: Departments are reminded to report any spills or usage of AFFF via ImageTrend or by contacting an OSFM Foam Analyst. Contact details are available on the OSFM website under the AFFF section.

# OSFM Launches Initiative to Support Fire Departments with ISO Ratings

The OSFM Ratings and Inspections Division is spearheading a new initiative to assist fire departments that have yet to undergo an ISO rating inspection. This effort aims to help departments achieve a better rating than Class 9, which can lead to lower insurance premiums and enhanced fire protection services for their communities.

# New Edition of North Carolina State Building Code Set for 2025 Rollout

OSFM Building Codes and Interpretations Section is hard at work finalizing the 2024 North Carolina State Building Code. The comprehensive suite of 10 codes is expected to become effective on July 1, 2025, marking a significant update to the state's construction and safety regulations.

The current suite of 11 codes, which make up the 2018 North Carolina State Building Code, will remain in effect through June 30, 2025. This overlap ensures a smooth transition for industry professionals, designers, and contractors as they prepare to adopt the updated codes.

Both online and print versions of the 2024 North Carolina State Building Code are anticipated to be publicly available during the first quarter of 2025. These resources will provide essential guidance for building and safety compliance across the state.
