A2L Refrigerants-Overview



Although there have been some re-submission requirements due to formatting, the January 1, 2024 adoption date has slid a little, but the effective date of January 1, 2025 is still the achievable goal with supplemental Building Code Council Meetings.

As of this writing, (June 2024) all code volumes have been submitted for review to the Rule Review Commission. Several volumes, including the NC Building Code, NC Fire Prevention Code, and NC Existing Building Code, were provided an extension for review by the RRC. The following list provides the status of the code volumes to date.

The RRC attorney requested and was granted an extension for review at the 4/30/2024 RRC meeting. It is expected this code will be voted on by the RRC at the 6/26/24 RRC meeting.
Fire Prevention Code	2024 NC Fire Code: The NCBCC readopted this code at the 3/19/24 meeting. Resubmitted this code to RRC on 3/19/24. The RRC attorney requested and was granted an extension for review at the 4/30/2024 RRC meeting. It is expected this code will be voted on by the RRC at the 6/26/24 RRC meeting.
Energy Code (not for 1- and-2 family dwellings)	2024 NC Energy Conservation Code: Approved at the 4/30/24 RRC meeting with the exception of Section R402 Building Thermal Envelope. More than 10 letters of objection were received by the RRC so this code is under legislative review in the 2025 long session. The effective date of this is unknown at this time.

Remember, the Residential standing committee had introduced (in the March 2023 meeting) a submittal that would keep the Chapter 11 (Energy), Chapters 12-23 (Mechanical) and Chapter 24 (Fuel Gas) the same as the 2018 version of the NC Residential Code. As noted in the previous newsletter, NCGS Session Law 2023-108 prohibits further action on several of the code volumes and combinations of code volumes that were being considered by the Building Code Council. The list of codes in Table 1 reflect the limitations of the statutes.
