- describe how the nominee has been an outstanding leader in efforts to benefit fire and life safety education.
- explain how the nominee has made a difference in fire and life safety education in North Carolina.

Entries will be evaluated by the NCFLSE awards committee.

The award will be presented during the North Carolina Fire & Life Safety Education Conference.
